

Terms & Conditions

1. The **\$99 Car Promotion** is conducted by City Motors ABN 784 328 63176 located at 505 Newcastle Street, Northbridge WA 6000, a dealership of Automotive Holdings Group Limited (AHG).
2. During the Promotion, City Motors will advertise a registered, used motor vehicle with a purchase price of \$99 once per calendar month randomly in the West Australian newspaper (the 'Vehicle'). On the day that the Vehicle is advertised ('Draw Day'), any person who is eligible to purchase the Vehicle in accordance with clause 5 below may complete an 'Expression of Interest' form and deliver it by hand to City Motors' premises by no later than 9 p.m. on Draw Day to enter into the draw for that Vehicle ('Draw'). The winner will be drawn the following business day (Draw Day) and will be notified as soon as possible thereafter.
3. By submitting an Expression of Interest form for any Draw, you acknowledge that you have read and understood, and agree to be bound by these conditions.
4. Additional details of the relevant advertised Vehicles are available upon inquiry at City Motors.
5. To be eligible to participate in the Promotion, you must:
 - a. be a resident of Western Australia;
 - b. be over the age of 18; and
 - c. have a current valid Australian driver's licence.
6. Employees of City Motors and members of their immediate families are ineligible to participate in the Promotion. There is a limit of one entry per person per Vehicle. City Motors reserves the right to verify the validity of entries and to disqualify any entrant who tampers with the entry process or who submits an entry that is not in accordance with these conditions.
7. The winner of a Draw ('Winner') will be entitled to purchase the relevant Vehicle for \$99 (the 'Purchase Price') pursuant to the standard terms and conditions that apply to the sale of used cars in Western Australia ('Standard Offer to Purchase'). When the Winner enters into a Standard Offer to Purchase for the purposes of these terms and conditions they become the 'Purchaser'. If the Winner fails to enter into the Standard Offer to Purchase **within 2 business days** of the date the Winner was notified, the Winner will forfeit their entitlement to purchase the Vehicle and City Motors will conduct a re-draw to determine another Winner.
8. City Motors will announce each Purchaser the week following the relevant Draw in the West Australian newspaper and on the City Motors website with a photo of the Purchaser and the Vehicle. Purchasers agree to make themselves available for these and any other reasonable publicity purposes at a time to be specified without charge.
9. In addition to the Purchase Price the Purchaser will be liable for all statutory charges associated with the Vehicle including stamp duty, transfer fee and re-registration of the Vehicle when it falls due. The Purchaser acknowledges that stamp duty is calculable on the market value of the Vehicle to the extent that it differs from the purchase price, and that it is the responsibility of the Purchaser to declare market value when paying stamp duty.
10. With respect to registration of a Vehicle, City Motors guarantees only that registration is valid up to and including the day the Winner is notified that they have won the Draw.
11. The Purchaser is liable for any expenses incurred in having the Vehicle delivered to a location other than City Motors, any options or extras additional to those advertised, petrol and all other ancillary costs.
12. Vehicles are not exchangeable, transferable or redeemable for cash.
13. City Motors takes no responsibility for any mechanical, body or paint repairs from the delivery date as specified in the Standard Offer to Purchase and accepts no other liabilities in relation to a Vehicle, other than those liabilities prescribed by the Motor Vehicle Dealers Act 1973 (WA) or any other applicable legislation.
14. As a result of you submitting an 'Expression of Interest' form, City Motors will collect certain personal information about you, such as your telephone number and email address. Unless you object, this information may be used to send you news, information about other promotions or products and/or general marketing material which City Motors believes may be of interest to you. If you wish to stop receiving information, you may do so in writing at any time info@citymotors.com.au and your details will be removed from the City Motors' database. By submitting an 'Expression of Interest' form, you consent to us using and disclosing your personal information in these ways.
15. These conditions constitute the entire agreement between you and us as to its subject matter. By participating in the Promotion, you accept that this agreement is to be interpreted, and any disputes are to be determined by the courts having jurisdiction in Western Australia, in accordance with the laws in force in Western Australia from time to time.
